

Interested eligible bidders may obtain complete set of a bidding documents containing description of item, specification & schedule, bidder eligibility & qualification requirements/terms & conditions on payment of Rs. 1,000/- in cash from Accounts Section of National College of Arts, 4 – Shahra e Quaid e Azam, The Mall, Lahore.

3. Bidder(s) are required to bid for entire (100%) quantity of the items/equipment. Conditional or incomplete bid based on partial items and quantity shall not be entertained.

4. Single stage-two envelope procedure as set out in Rule No. 36 of Public Procurement Rules, 2004 shall apply. "Technical" & "Financial" bids in separate sealed envelopes shall be submitted. The "Financial Bid" must be supported with an Earnest Money/Bid Security i.e., 2% of the bid value in the shape of Bank draft/Call Deposit/Demand Draft/Banker's Cheque in the name of 'Principal - National College of Arts'. Technical & Financial shall be delivered to the address given below on or before 1100 hours by 25<sup>th</sup> of May, 2021. Late bids shall not be accepted. Bids will be opened on the same date at 11:30 hours in the presence of the bidders or their authorized representatives, who may choose to be present.

5. The bidders are requested to give their best and final prices inclusive of all applicable Taxes against all items provided in price schedule as no negotiations on the price is allowed. The college may reject all bids at any time prior to the acceptance of a bid by invoking rule 33 of Public Procurement Rule (PPR), 2004. In case public holiday is announced on bid submission & opening date the same shall be held on the next working day.
