- Valid documents/copies of registration with SECP along with Articles of Association and Memorandum of Association in case of single member Company i.e SMC (Pvt) Ltd and Private Limited Company & duly registered 'Partnership Deed 'with Registrar of Firm in case of a partnership firm/association of person .
- Valid registration certificates with tax departments and certificate of active taxpayer.
- Particulars of registration with Government, Semi Government and Autonomous bodies showing establishment.
- List & CVs of permanent staff employed by the company.
- List and cost of projects in hand, including name of the client and scope of work.
- Firm must be completed at least 02 project of similar size and complexity as a contractor or sub contractor with a minimum value of Rs.800.00 Millions each during last five years with any authority and organization.(letter of award alongwith signed BOQ cost & Completion Certificate must be clearly attested by the BPS -17 or above Govt Officer)
- Detail of similar works successfully executed stating nature, magnitude and complexity within the last five (05) years.
- Financial statement cash flow statement and balance sheet of the last three (03) years, supported with audit report by chartered accountant.
- Certificate from the bank(s) showing confirmed line of credit greater than 200 Millions. alongwith bank references ,Average annual construction turnover for the last three (03) years, to be not less than Rs.800.00 Millions
- List of plant, equipment and machinery owned by the company.
- Litigation history with departments (if any).
- Affidavit on non-judicial stamp papers of Rs. 100/- that the company has never been blacklisted.
